Appendix 2 – Application for Discretionary Funding

To assess eligibility, applicants must provide evidence of household income, which must be below £35,000, unless there has been a sudden, exceptional change in circumstances. Household income includes gross taxable earnings and any taxable benefits. If a young person lives with parents, carers, or a partner, their income will be considered. If living independently, the young person must provide evidence of their own income and benefits.
